

Gun Raffle

Official Rules

Prize is a Sig Sauer P365, 9mm, black finish. Prize package MSRP is approximately \$600.00.



- Drawing to be held Thursday December 12, 2024. Need not be present to win.
- Raffle tickets are \$10.00 each. The purchase of only one raffle ticket is required to enter the raffle. Sponsor, in its sole discretion, may disqualify any individual who tampers with the entry process, cheats, or otherwise attempts to undermine the legitimate operation of the raffle.
- Raffle is open only to legal residents of the United States. Participants must be at least 21 years of age or older.
- Sponsor (St Louis Shooting Club DBA St Louis Schützenverein), in its sole discretion, may disqualify any individual who tampers with the entry process, cheats, or otherwise attempts to undermine the legitimate operation of the raffle.
- By purchasing a raffle ticket, you certify that you are eligible to enter agreeing to be bound by the raffle rules, and all federal, state, and local laws as applicable. Missouri residents must be 21 years of age for transfer of handgun by FFL. Please check your state and local rules before purchasing a raffle ticket.
- No refunds. All proceeds from the raffle will support the St. Louis Shooting Club (DBA St. Louis Schützenverein); a not-for-profit organization recognized in the state of Missouri. Your donation toward the purchase of a ticket is not considered tax deductible.
- At the time of the drawing, the club shall draw a ticket for the winner and a second chance ticket winner. In the event the winner does not meet or comply to

the rules regarding notification, the second chance ticket holder will be notified, and shall comply with rules outlined in this document. In the event neither the winner nor the second chance winner complies with the rules set to obtain the firearm, it will be forfeit to the St Louis Schützenverein.

- All tickets must include a phone number as we will attempt to notify the winner by phone. Phone numbers are collected for notification purposes only and shall be destroyed upon certification of completion of the raffle.
- If winner does not respond within 5 business days of phone call and voicemail message, the prize shall be forfeited. The Sponsor is not responsible for phone call filtering or insufficient space in any voicemail box. The winner of the firearm shall not be compensated, nor raffle ticket money be refunded in the event the winner is determined to be ineligible.
- Prize must be claimed with in forty-five (45) days from the date of the drawing. Prize/s not claimed will be forfeit to St. Louis Schützenverein.
- Persons under the age of 21 may not purchase a raffle ticket or win a firearm. In addition, all federal, state, and local laws apply. The winner is responsible for contacting Southern Armory. Southern Armory will be responsible for transfer of the firearm to the prize winner and will be responsible for the determination of eligibility of the winner. An FFL fee is applied to all out of state winners. Prize winners are responsible for any fees (shipping, FFL transfer, taxes, etc.)
- If winner does not respond within 5 business days of phone call and voicemail message, the prize shall be forfeited. The Sponsor is not responsible for phone call filtering or insufficient space in any voicemail box. The winner of the firearm shall not be compensated, nor raffle ticket money be refunded in the event the winner is determined to be ineligible.
- Prize must be claimed within forty-five (45) days from the date of the drawing. Prizes not claimed will be forfeited to St. Louis Schützenverein.
- The St. Louis Schützenverein is not responsible for lost, delayed, late, illegible, incomplete, or corrupted entries, inaccurate or incorrect entries or entry information, or any other human or technical errors of any kind relating to the submission, collection, or storage of entries.
